1 On January 26, 2018, this Court gave final approval to the partial class settlement between
2 Plaintiffs Eileen and Richard Lodyga and Holly Wedding (collectively "Plaintiffs"), and
3 Defendants Towers Watson Co., Towers Perrin, and Tillinghast-Towers Perrin (collectively
4 "Towers Watson") and entered its Order Granting Final Approval of Class Action Settlement (the
5 "Final Approval Order").

6 Accordingly, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:

7 1. The Settlement Class is defined as all California citizens who purchased long-term
8 care policies from the California Public Employees Retirement System ("CalPERS") between
9 1995 and 2004, who were subject to the 85% premium increase announced to policyholders in or
10 around February 2013 and implemented beginning in 2015.

11 2. One-hundred sixty-nine (169) members of the Settlement Class timely requested to
12 be excluded from the Settlement Class prior to the deadline on October 14, 2016. A list of
13 members who requested exclusion is attached as Exhibit 1 hereto.

14 3. Plaintiffs Eileen and Richard Lodyga, Holly Wedding and all members of the
15 Settlement Class shall take from their complaint as to Towers Watson only the relief set forth in:
16 (a) The Second Amended And Restated Joint Stipulation For Class Action Settlement As To
17 Towers Watson Defendants (the "Settlement Agreement"), a copy of which is attached as Exhibit
18 A to the Amended Order Granting Preliminary Approval of Class Settlement Between Plaintiffs
19 and Towers Watson Defendants ("Preliminary Approval Order"), dated October 25, 2017; and (b)
20 the Final Approval Order, filed on January 26, 2018.

21 4. Except as to the Towers Watson Defendants and those individuals and entities
22 identified in paragraph 11 of the Settlement Agreement, this Judgment does not release or affect
23 in any manner any claims or rights that Plaintiffs and the Class have or may have against any
24 other defendant or potential defendant, including but not limited to CalPERS.

25 5. This Judgment is intended to be a final disposition of the above-captioned action
26 as against Towers Watson only, and is intended to be immediately appealable.
